#### MET-LIFE/OPEN ENROLLMENT

Reminder, open enrollment for Life Insurance is April 27 – May 26, 2023. Representatives from Met-Life will be scheduled in the plant. Further information will be forthcoming.

#### **ADDRESS UPDATES**

Reminder to make sure your address is current and updated in the Plant and at the Union Hall. Important upcoming 2023 UAW Local 1250, General Election Information will be mailed to your address on file.

### **PROFIT SHARING**

Under the provisions of the 2019 UAW-Ford Collective Bargaining Agreement, all eligible hourly employees will receive a Profit-Sharing payment on **March 9, 2023**, Profit-Sharing payments will follow the distribution process of regular paychecks.

Ford's North American pre-tax profits will generate approximately \$9,176 per eligible employee on a full-year basis. Individual Profit-Sharing payments will be higher or lower, based upon employee compensated hours.

Compensated Hours include hours that an eligible employee receives pay within the Plan Year for:

• Base Pay, Overtime (with each hour paid at premium rates to be counted as one hour), Vacation, Holiday, Bereavement Jury Duty, Short-term Military Duty, Family Day

You may elect your profit-sharing payment from three options. *CASH* (direct deposit, check), *TESPHE or FIA* (Ford Interest Advantage). Elections must be made in whole percentages, not a fixed dollar amount, and must equal 100% (example: 50% cash, 50% TESPHE). You may elect to contribute all or a portion of your profit-sharing payment to your TESPHE account, on either a pre-tax or Roth basis, subject to regulatory limits.

You must choose how you want to receive your 2023 Profit Sharing payment by:

#### Friday, February 24, 2023, at 4:00 pm Eastern time

If you have existing bonus election(s) on myfordbenefits.com, your Profit-Sharing payment will utilize your latest election.

<u>Note:</u> If you have outstanding child support or any other QDRO, any election you make to contribute all or a portion of your Profit-Sharing payment to TESPHE will not be processed.

- Cash payments (e.g., check, direct deposit, or deposits to Ford Interest Advantage (FIA) notes) are subject to the following deductions:
- Federal income taxes -22% (regardless of the number of claimed exemptions and exempt status)
- Social Security and Medicare taxes 7.65%
- State and local taxes
- Child support arrearages
- Bankruptcy payments
- Garnishments, wage deduction orders
- Federal or state levies
- Union dues
- Money owed to the Company

Contributions to TESPHE for 100% of the Profit-Sharing payment will be subject to applicable Social Security taxes which will be deducted from the next regular paycheck.
