ATTENTION

Due to the current UAW Stand Up Strike at other locations that we supply. The Company has blatantly disregarded our seniority agreements and has decided to Layoff the I-4 Department and ignoring our seniority agreements. The National Ford Department will be filing Unfair Labor Practice charges against the Company regarding this matter.

For those affected by this unprecedented layoff situation, here is what you will need to do: Below is a message we received from ODJFS.

NOTE FROM OHIO UNEMPLOYMENT

We would encourage your membership to file their applications for benefits or their continued claims. Also, they should report any other income received/earned while on layoff. A determination of benefits will be issued based on the effective date of the labor dispute.

There will be **NO MASS LAYOFF NUMBER**

If you are Laid Off, you will also be required to register at the Union Hall for Strike Assistance Pay. Registration for Laid Off Workers will be at the Union Hall,

Special Election for Executive Board Vacancies

With the resignation of Jack Federan, Financial Secretary, please be advised that we are following the Constitution and Local By-Laws pertaining to this vacancy. We have been granted an extension from the Regional Office to hold this Special Election after Contract and Strike issues have been resolved.

ARTICLE 38 Local Union Officers

Section 1. Each Local Union shall have the following Executive Officers: President, Vice President or Vice Presidents, Recording Secretary, Financial Secretary, Treasurer, three (3) Trustees, Sergeant-at-Arms and Guide. Should one or more of these officers be absent, the absent officer(s) shall be temporarily replaced by the next officer present, following the above order of hierarchy.

Local Union Bylaws

Article IV, Section 5 –

All vacancies of Local Union offices, except the office of President, shall be filled by election (within 45 days), provided that the Local Union Executive Board may make a temporary appointment, for the period pending the holding of the election.
