### 2017 Inflation Bonus

Eligible hourly employees will receive the 2017 Inflation Bonus Lump Sum Payment of \$1500 during the week of June 11<sup>th</sup> 2017. **Full time** hourly employees on the active employment roll are eligible if they have acquired seniority (completed their 90 day probationary period) as of May 15<sup>th</sup> 2017.

Short-Term Supplemental or Temporary Part-Time non seniority employees are **not** eligible for an inflation Bonus Lump Sum Payment.

Eligible seniority employees on the active roll on personal or medical leave of absence, FMLA leave, temporary layoff, or short-term military duty on May 15<sup>th</sup>, 2017 will receive an Inflation Bonus Lump Sum Payment.

The Inflation Bonus Lump Sum Payment will be paid in a separate check and will be either direct deposited or mailed to the employees address on record on Friday, June 9<sup>th</sup>, 2017. The TESPHE election is available for this payment.

### Standing Committees

Per Article XVII of our Local Union Bylaws, our local Union shall have Standing Committees that serve for a period of three years, each standing committee is to meet after or before working hours at least once a month or as needed. All standing Committees are to submit written reports to the President and the Executive Board and will elect their own Committee Chairperson, Secretary and Treasurer from among their Committee.
